4. The program(s) have been granted provisional accreditation. Jyothi Engineering College, Jyothi Hills, Panjal Road, Vettikattiri P.O., Cheruthuruthy, Thrissur, Kerala-679531 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifier before sending the Compliance report for granting further Accreditation.

The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Jyothi Engineering College, Jyothi Hills, Panjal Road, Vettikattiri P.O., Cheruthuruthy, Thrissur, Kerala-679531 as a whole. **As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
